


PATERNO & ZOBEL WIN COLOR PICTURES OF THE YEAR

1984 Master Photographer Bobby Paterno and 1978 & 1980 Master Photographer Jaime Zobel won the top honors in the color finals held last Monday November 5th at the San Lorenzo and Dasmariñas Rooms of the Hotel InterContinental Manila. Paterno, who is also the 1984 Color Slide Photographer of the Year, fittingly saw one of his transparencies awarded the title "Color Slide of the Year." It was a surrealistic-looking landscape of a desolate volcanic area in Hawaii cut by a long curving wooden boardwalk. Zobel, on the other hand, won the "Color Print Picture of the Year" with a romantic gel-misted soft portrait of two young girls by a carved stone fountain.

Taking 2nd place among the slides was Bien Bautista's mourning hands clutching a folded Philippine flag, while third place went to Dik Trofeo's landscape of the extraordinarily shaped hills of Kweilin, China. Among the color prints, 2nd place went to Francis Rivera's pole-top view of a *palosebo* crowd at Lukban and 3rd place to an unusual still life by Bo Villanueva.

In the color slide finals which included more than four hundred qualifiers throughout the year, the patient and conscientious judges who sat through no less than four viewings were Mrs. Eduviges Y. Huang, professional photographer and Past President of the Professional Photographers Association of the Philippines, Mrs. Carol Stratton, a well-

travelled researcher and author on Asian, especially Thai, art, and Prof. Rafael Asuncion, former creative director for advertising firms and now Professor of Visual Communications at the College of Fine Arts of the University of the Philippines and practising painter. After two viewings, the judges narrowed down the field to 137 slides out of which they chose the winners.

In the color print finals which included 174 prints, the panel of judges was composed of Dr. Rodolfo P. Perez, an art historian and author with a doctorate from Harvard University, former professor at the U.P. College of Fine Arts, world-renowned woodcut print maker now connected with the Research Department of the National Library; Prof. Romeo C. Mananquil, Chairman of the Department of Visual Communications of the U.P. College of Fine Arts, painter, illustrator, cartoonist, amateur photographer and designer of the new Central Bank notes and coins; Mr. Ramonlito Abaño, Advertising, Promotions and Publicity Manager of SM Shoemart, Inc.

'VIEWFINDER' WINS PSA HONORS AGAIN

These last three years, the CCP has been submitting samples of its club bulletin to the International Bulletin Contest of the Photographic Society of America's Camera Club Committee, and each year the CCP's publication has been winning higher and higher awards.

In 1982, when the monthly bulletin (as distinguished from the sometimes quarterly folio magazine *Viewfinder*) first came to be in printed form under President Ramon Marcos, the CCP submitted the January, February and March 1982 issues to the PSA. That year, a total of 272 entries were submitted from all over the world, out of which 155 were classified as coming from "large clubs." The CCP is classified under the "Large Club Division," and its







bulletin scored 258 out of a total 465 points possible, ranking it 58th out of 155 large club bulletins. The CCP *Bulletin* also received a "Creative Award" ribbon that year, expressly for the "use of prints and illustrations."

In 1983, under President Luis Abiva, Jr.'s administration, the monthly bulletin was merged with the old magazine-format *Viewfinder* under the latter title. For that year, the fancier *Viewfinder* was ranked as a 27th tie placer among the large clubs, thus winning an Honorable Mention award. And it won the "Most Creative Bulletin" plaque award. That year a total of 315 entries were received from all over the world.


For 1984, the club submitted the November-December 1983 issue of the *Viewfinder*, because of the May cut-off date of the contest. This time, the *Viewfinder* was ranked 15th out of 151 entries from the "Large Club Division," earning 360 out of a possible 453 points, thus garnering an Honor Award. It also was awarded one out of only two Chairman's "Most Creative Bulletin" plaques. There were a total of 282 entries competing internationally.

In 1982, the members most responsible for the bulletin were Bobby Paterno and Emil Davocol. With regard to the entries for 1983 and 1984, the members most responsible were Quincy Castillo, Louie Abiva and Emil Davocol.


Manny Arriola showing his "demonstration slides."



SPECIAL RULES FOR 1985 REGULAR MONTHLY CONTESTS

January 7

CHRISTMAS (Color Slide)

A photograph depicting any aspect of Christmas or the Christmas season anywhere in the world.

February 4

OPEN (Black & White)

A photograph on any subject matter.

March 4

LANDSCAPE/SEASCAPE (Color Print)

A photograph of scenery on land or water, or a combination of both.

April 1

PORTRAIT OF A YOUNG WOMAN (Black & White)

1. A portrait photograph of one female person of any nationality between the ages of 13 to 39 years.
2. As a portrait, the photograph need not emphasize but must show the face, with or without a setting.

May 6

RED (Color Slide)

A photograph with an element of red.

June 3

CHURCHES (Color Print)

A photograph of a church, chapel, temple, or mosque, or part thereof, exterior or interior.

July 1

FIESTA (Color Slide)

A photograph depicting an aspect of a religious or folk festival, Filipino or otherwise.

August 5

PORTRAIT (Color Print)

1. A portrait photograph of any person or persons of any age, sex, or nationality.
2. As a portrait, the photograph need not emphasize but must show the face or faces, with or without a setting.

September 2

STILL LIFE (Black & White)

1. Arrangements or composition of originally inanimate objects such as bottles, statuettes, lighted candles, and the like.
2. Arrangements or composition of originally living things but now dead or inanimate such as dried fish, plucked fruits in a bowl, cut flowers in a vase, cut tree branch, and the like.

6. **Color Slide Photographer of the Year:** 1st, 2nd and 3rd Places for the photographers with the highest totals of qualifying scores in the January "Christmas," May "Red," and July "Fiesta," and in two (2) of the on-the-spot competitions where the photographer concerned scored best.
7. **100% Qualifier Award:** To all who submit two entries in all regular monthly contests and earn qualifying scores for all of them without exception.
8. **Black and White Picture of the Year:** 1st, 2nd and 3rd Places to the pictures so chosen by the judges in the Black and White Print Finals in October among all qualifiers for the year.

9. **Color Print Picture of the Year:** 1st, 2nd and 3rd Places to the pictures so chosen by the judges in the Color Print Finals in November among all previous qualifiers for the year.
10. **Color Slide Picture of the Year:** 1st, 2nd and 3rd Places to the pictures so chosen by the judges in the Color Slide Finals in November among all previous qualifiers for the year.
11. **Photographer of the Year:** *The Ayala Cups* for the 1st ("Master Photographer of the Year"), 2nd and 3rd Places for those accumulating the three highest totals of qualifying scores in the nine (9) regular monthly contests and two (2) of the on-the-spot competitions in which they scored best. *Medals* for the 4th to 10th Places, inclusive.

GENERAL RULES FOR 1985 REGULAR MONTHLY CONTESTS

1. Any member in good standing and not on leave of absence may enter the monthly contests.
2. A maximum of two (2) entries per member are allowed in each contest, unless otherwise specified.
3. All entries must be submitted on or before 1:00 PM (by the Club's office clock) on the contest-meeting day at the Club office at JLM Electronics, 1782 Nicanor Garcia (formerly Reposo) St., Makati, Metro Manila.
4. In Black & White and Color Print competitions, entries must be printed on 11" x 14" paper and unmounted so that they can be accommodated in the Club's exhibit mechanism. Entries may be with or without borders, and borders may be of any size or shape. Nothing may be pasted on the surface of the picture.
5. In the case of toned black and white prints, only sepia or brown tone is acceptable.
6. In the color slide medium, entries may be in 35 mm. format or "super slide" format, uncropped or cropped in any way desired, provided they are on 2" x 2" mounts which fit the Club's Kodak Carousel 80-slide tray and slide projector. "Sandwiched" slides are not allowed.
7. All slides should have a dot marker on the lower left-hand corner of the slide mount when the slide is viewed in the manner the photographer wants it projected on the screen.
8. Titles are optional, but must not be allowed to appear in front of or on the photographs.
9. All entries should bear the name of the photographer, on the mount in case of slides and at the back in case of prints. Titles, if any, should also be on the mounts of slides and on the back of prints.
10. The Minimum 3-Point Qualifier System will be used in scoring. Each entry will be judged on a scale of 1 to 5. The score of each entry shall be the average of the scores given by all the judges, and only entries garnering average scores of 3.0000 and above will be "qualifiers" and will be considered in the scoring for the various individual contests, annual medal and trophy competitions, and for the finals. Average scores will be computed and recorded up to and not beyond the 4th decimal place. There shall be no rounding off.
11. All entries, whether qualifiers or not, shall remain in the custody of the Club for at least two years unless returned earlier by specific decision of the Board. This is to provide material for Club photo exhibits and publications.
12. All entries that have not qualified in any earlier competition may be entered in another contest.
13. No photographs by the same photographer that have previously qualified shall be allowed to be entered in any contest in any medium. The Contest Committee may disqualify any photograph if in the Committee's judgment the entry is in whole or in part the same as a previous qualifier by the same photographer.
14. No photograph published or publicly exhibited in the Philippines previous to a monthly contest may be entered in said contest. The Contest Committee may disqualify any entry which in the Committee's judgment is in whole or in part the same as one previously published or exhibited.
15. The Contest Committee may disqualify any entry, which in the Committee's judgment, does not comply with these General Rules or the Specific Rules for the particular contest concerned.
16. Any complaint by any member regarding a particular contest, must be submitted in writing at the Club's office addressed to the Board no later than the Thursday immediately following the contest date. After said deadline, no complaint of any kind shall be entertained.
17. At any time before and during the judging in any contest, all members must refrain from any action or comment which may reveal to any judge the identity of the photographer of any particular entry or which may tend to bias in any way or unduly influence the decision of any judge.

AWARDS FOR 1985

MONTHLY AWARDS

1. The member garnering the highest total of average scores for his qualifier entries in a particular monthly contest shall receive the *Photographer of the Month* award, while the single qualifier entry that scores the highest will receive the *Picture of the Month* award.
2. At on-the-spot competitions, there will be one *Best Photographer* award for the member with the highest total average scores for his qualifier entries and there shall be one *Best Picture* award for the single qualifier photograph which scores the highest.

ANNUAL AWARDS

(Note: Unlike previous years, there will be no "Landscape Photographer of the Year" awards in 1985).

1. **Portrait Photographer of the Year** (Dr. Alejandro R. Legarda Award): 1st, 2nd and 3rd Places for the photographers with the highest totals of qualifying scores in the April "Portrait of a Young Woman" and August "Portrait" contests.
2. **Special Theme Photographer of the Year** (Dr. Gregorio B. Sison Award): 1st, 2nd and 3rd Places for the photographers with the highest totals of qualifying scores in the January "Christmas," May "Red," June "Churches," July "Fiesta," and September "Still Life" contests.
3. **On-the-Spot Photographer of the Year** (Dr. Miguel J. Heras Award): 1st, 2nd and 3rd Places for the photographers with the highest totals of qualifying scores in *all* on-the-spot competitions of the year.
4. **Black-and-White Photographer of the Year**: 1st, 2nd and 3rd Places for the photographers with the highest totals of qualifying scores in the February "Open," April "Portrait of a Young Woman," and September "Still Life" contests.
5. **Color Print Photographer of the Year**: 1st, 2nd and 3rd Places for the photographers with the highest totals of qualifying scores in the March "Landscape/Seascape," June "Churches," and August "Portrait" contests. →

CAMERA CLUB OF THE PHILIPPINES MEMBERSHIP RULES *

Article I. Membership

SECTION 1. There shall be five classes of members in the Club as follows:

- (a) Regular Members
- (b) Lifetime Members
- (c) Subscribing Members
- (d) Honorary Fellows
- (e) Probationary Members

Article II. Regular and Lifetime Members

SECTION 1. Only Regular Members and Lifetime Members shall be considered "members" of this corporation in the sense of the Articles of Incorporation and By-Laws of the corporation, having all the full rights, privileges, and duties and obligations of "members" as provided for in said Articles of Incorporation and By-Laws. Subscribing Members, Honorary Fellows and Probationary Members shall have such rights, privileges, and duties and obligations as are specifically provided for in these Membership Rules.

SECTION 2. A Regular Member, to maintain his status as such, is expected to attend at least three (3) regular monthly members' meetings annually, and to compete in at least three (3) Club competitions annually, provided that he may freely substitute additional attendance for the competition requirements and vice versa. In other words, every Regular Member is required to maintain annually a minimum of six (6) instances, in any combination, of personal attendance at regular meetings and/or participation in club competitions.

SECTION 3. A member whose combined Regular and Subscribing Membership in the Club has reached a total of twenty-five (25) years shall automatically become a Lifetime Member, provided he has been a Regular Member for a total of at least five (5) years.

SECTION 4. Members who have been elected Lifetime Members by earlier Boards of Directors or by the general membership prior to the promulgation of these Rules of Membership shall be recognized as such.

SECTION 5. A Lifetime Member shall have all the rights and privileges of a Regular Member. However, he shall not be required to discharge the duties and perform the obligations required of a Regular Member provided for in Section 2 above of this article, nor shall he be required to pay Regular Membership dues. He

may, however, be required to pay assessments for actual attendance at special functions of the Club, dinner fees, contest participation fees and the like.

Article III. Application Procedures

SECTION 1. Every person wishing to join the Club shall apply for membership to the Board of Directors through the Secretary in writing on the approved form or forms for said purpose.

SECTION 2. Each application must be accompanied by a written sponsorship from a Lifetime Member or a Regular Member of at least three (3) years standing, and a seconding from another Regular Member of at least one (1) year standing.

Article IV. Admission of Probationary Members and Conversion to Regular Membership

SECTION 1. No person shall be admitted as a Regular Member without passing through at least a year as a Probationary Member.

SECTION 2. The Board may at its discretion either accept an application for further processing or may reject the same, provided always that no application of a previously rejected candidate shall be accepted for consideration within twelve (12) months after a previous rejection. In case of rejection, the Board shall so notify the applicant, and no reason need be given.

SECTION 3. In case of approval for further processing, the Secretary shall notify the applicant to this effect, enjoining him to attend at least three regular monthly members' meetings within the next five-month period during which time the sponsor and seconder should make an effort to make him known to the members of the Club.

SECTION 4. Upon approval for further processing, the Secretary shall also circularize all Lifetime and Regular Members to the effect that the applicant has been approved for further processing and that any member with any objection against said applicant shall have at least the period covered by the next three monthly meetings to submit such objection to the Board.

SECTION 5. At its regular meeting after the third of these three regular monthly members' meetings attended by the applicant, the Board shall proceed to accept or reject such candidate for Probationary Membership, provided that if in the interim the Board shall have received, in writing, a notice or notices of objec-

tion to that candidate's admission signed by two (2) or more Lifetime or Regular Members, then the candidate's application shall be automatically rejected, and the applicant so notified, and no reason need be given. The names of the objectors shall not be recorded in the minutes of the Board meeting, their written objection shall be returned to them, and their identities shall not be divulged by anyone in the Board.

SECTION 6. The accepted candidate shall be informed of his election as Probationary Member by a letter from the Secretary. Such candidate shall not be admitted as Probationary Member until all prescribed dues and fees shall have been paid.

SECTION 7. A Probationary Member shall possess all the privileges of a Regular Member except the right to vote or be elected as Director of the Club and to sponsor or second applicants for membership.

SECTION 8. Any arrears in Club dues, fees and/or assessments of a Probationary Member incurred during his period of probation shall be answered for and paid to the Club by the sponsor.

SECTION 9. Probationary Members may be considered for conversion of their status to Regular Membership when the following prerequisite conditions are successfully met by the Probationary Member:

- (a) Completion of at least twelve (12) months of probationary status;
- (b) Attendance at no less than nine (9) members' meetings during a year's period. Any absence from any scheduled members' meeting and reasons therefor must be reported in writing by the Probationary Member concerned to the Board of Directors through the Secretary; the probationary period shall be extended by at least one month for every regular monthly meeting missed;
- (c) Participation in at least seven (7) of the Club's competitions during a year's period, and earning a minimum number of competition (not necessarily qualifying) points during a year's period, such minimum to be set by the Board at the start of the probationary period;
- (d) Prompt and full payment of all prescribed dues, fees and assessments;
- (e) Demonstrated personal cooperation and participation in club activities, projects, fellowship and camaraderie;
- (f) Fulfillment of reasonable assignments given by the Board and officers of the club;
- (g) Behavior in consonance with the ideals and objectives of the Club.

SECTION 10. The Board shall, at the end of the probationary period, deliberate on the merits of each Probationary Member's performance for the year.

SECTION 11. The name of any Probationary Member to be consi-

dered for regularization shall be circularized to all Lifetime and Regular Members at least fifteen (15) days prior to the scheduled Board meeting when such regularization will be voted upon.

SECTION 12. Any objection to the proposed regularization on the part of a Lifetime or Regular Member must be submitted in writing to the Board at or before the scheduled Board meeting referred to in Section 11 above of this article. If no objection is filed, the Board shall, by majority vote, approve or disapprove the regularization. If any objection is filed, and the Board, by majority vote, is not disposed to disapprove the regularization, then the Board shall bring the matter before the general membership at a regular or special meeting and the question shall be decided by majority vote of the Lifetime and Regular Members present at said meeting, provided notice of such meeting and question to be decided upon has been previously announced in accordance with the by-laws of the Club.

SECTION 13. The final decision on the approval or disapproval of the conversion of a Probationary Member to Regular Membership shall be communicated in writing by the Secretary to the candidate concerned.

SECTION 14. Probationary Membership normally expires after one year if the member concerned is not made a Regular Member, and he is automatically separated from the club. However, in cases where the candidate for good and sufficient reason is unable to fulfill the requirements for regularization, the Board may extend the candidate's probationary period for a maximum period of one (1) additional year.

SECTION 15. A former Regular Member who has resigned in good standing, may apply for reinstatement and the Board may approve such reinstatement as Regular Member without necessity of passing through probationary status. Should the Board wish to reinstate such a member, the name of such candidate must be announced to all Regular and Lifetime Members in the Club bulletin or through circular. If within thirty (30) days, no notice of objection is filed in writing with the Board by any Regular or Lifetime Member, the Board may then finalize the reinstatement. If any notice of objection to such reinstatement is received, the Regular and Lifetime Members shall ballot on the candidate at a regular or special meeting, and the question shall be decided by majority vote of the Regular and Lifetime Members

present at said meeting, provided notice of such meeting and question to be decided upon has been previously announced in accordance with the by-laws of the Club.

Article V. **Subscribing Members**

SECTION 1. In the event that a Regular Member is unable to meet fully the obligations enumerated in Section 2, Article II above, he may apply to the Board to become, or the Board may on its own change his status to that of, Subscribing Member. Such member, when he is able to meet the normal obligations of a Regular Member, may again be reinstated by the Board of Directors to Regular Membership without necessity of passing through probationary status.

SECTION 2. A Subscribing Member may attend membership meetings of the Club, participate in Club competitions, exhibits, publications and social functions, but he shall not have the right to vote or be elected a Director of the Club, nor the right to sponsor or second applicants for membership. He shall be required to pay all Subscribing Membership dues and fees.

SECTION 3. No non-member may apply for admission to the Club as Subscribing Member without first becoming a Regular Member, provided that all who are Subscribing Members as of April 1, 1984, may continue to be so regardless of whether or not they have been Regular Members before.

Article VI. **Honorary Fellows**

SECTION 1. A person who has achieved attainment levels in the science or art of photography and has thereby distinguishing himself or who has provided extraordinary service to the ideals and objectives of the Club may, with his express consent and the approval of two-thirds of the Regular and Lifetime Members, be conferred the status of Honorary Fellow of the Camera Club of the Philippines.

SECTION 2. An Honorary Fellow shall have all the rights and privileges of a Regular Member, except the right to vote or be elected into the Board of Directors; nor shall he be required to pay membership dues.

SECTION 3. The status of Honorary Fellow shall automatically expire every end of the fiscal year of the Club, unless renewed by the incoming Board of Directors, provided no objection is filed by Regular and Lifetime Members. In case of an objection, a two-thirds majority of the Regular and Lifetime Members shall be required to extend the Honorary Fellowship.

Article VII. **Official Leave of Absence**

SECTION 1. For good and sufficient reason, Regular and Subscribing Members may be granted official leave of absence by the Board of Directors during which leave the member shall not be required to pay membership dues or perform other duties required of membership. A Maintenance of Membership Fee, however, the amount to be fixed from time to time by

the Board of Directors, shall be paid by such member during his leave of absence.

SECTION 2. Only Regular and Subscribing Members who have been Regular and/or Subscribing Members for at least three complete years may be granted an official leave of absence.

SECTION 3. A Regular Member on such approved leave of absence shall have his right to vote suspended during the period of his leave. He may be elected to office while on leave of absence provided he shall have reverted to active status at the start of the term during which he is to serve.

SECTION 4. Requests for leaves of absence should be commensurate with the reason or reasons for the same, and submitted in writing to the Board, and they shall be considered by the Board on a case-to-case basis and the Board's decision shall be transmitted in writing to the member concerned.

SECTION 5. A member may remain on leave for a continuous period of not more than two (2) years for every ten (10) year period. Exceptions to this rule may be granted by the Board of Directors only with the approval of a majority of the Regular and Lifetime Members.

Article VIII. **Suspension and Termination of Membership**

SECTION 1. A Regular or Subscribing Member whose dues and fees are in excess of one (1) month in arrears shall not be entitled to participate in the Club's scheduled competitions.

SECTION 2. A Regular or Subscribing Member whose dues and fees are in excess of three (3) months in arrears shall forfeit his membership and his name shall be removed from the Club's roster.

SECTION 3. Any member may resign from the Club by giving notice in writing of his resignation to the Secretary. Such resignation shall be accepted provided all his accounts with the Club have been settled.

SECTION 4. The Club may at its discretion expel any member from the Club; provided always that:

- (a) No proposal for the expulsion of any member shall be considered by the Club unless a notice or notices signed by ten (10) or more Regular and/or Lifetime Members requiring such expulsion and specifying the full reasons therefor shall previously have been delivered to the Secretary;
- (b) No member shall be expelled unless he shall have been given an opportunity to explain or rebut before a meeting of the Club the matters alleged against him in such notice or notices;
- (c) The Regular and Lifetime Members meeting in quorum, votes two-thirds to expel him from the Club; and
- (d) Before proceeding to expel a member the Board may at its discretion invite the member to resign from the Club.

SECTION 5. No action or proceedings whatever shall be brought by any member or former member in respect of any notice to the Secretary requiring his expulsion, or any proceedings or discussions of the Club related to his expulsion or proposed expulsion either against the Club or against any member.

SECTION 6. No former member expelled from the Club shall be reaccepted into the Club, provided that if a member has been dropped due to non-payment of dues and fees, he may be reaccepted provided all his outstanding accounts are subsequently settled and the same procedures for new application or reinstatement of former Regular Members shall be followed.
